#### General information

Advion® Cockroach Gel Bait is designed to control pest species of cockroaches and is effective against both adult and nymph stages. The slight delay in mortality caused by the active ingredient, indoxacarb, allows cockroaches to consume the bait and return to the harbourage site to contaminate other cockroaches, resulting in significant reduction in infestation levels. Following treatment of infested areas, cockroach death can be expected from 24 hours after application onwards.

- 1. Indoor use
- Advion<sup>®</sup> Cockroach Gel Bait should be applied in areas inaccessible to children or pets.
- Infested areas should be carefully inspected to determine overall infestation levels, locations of harbourage sites and most appropriate application points.
- Advion® Cockroach Gel Bait can be used indoors in both food/feed storage areas & non-food/ non-feed areas, applied as a crack & crevice treatment in and around residential homes, indus-trial facilities, offices, warehouses, commercial kitchens, hospitals, schools, nursing homes, hotels, buses, trains, aircraft, retails and commercial establishments, or at suitable placement sites that act as cockroach harbourages.
- Advion® Cockroach Gel Bait can also be placed inside approved bait stations, or similar devices, to ensure product is inaccessible to children or pets, and said devices should be placed in areas where cockroaches are active.
- 2. Outdoor use
- Advion® Cockroach Gel Bait should be applied in areas inaccessible to children, pets, non-target organisms & beneficial insects.
- A thorough inspection around a structure may reveal areas where cockroaches are gaining access: attempts should be made to block the access.
- Advion® Cockroach Gel Bait should be applied to pest entry sites such as around windows & doors, between construction elements, or at suitable placement sites that act as cockroach harbourages.
- Advion® Cockroach Gel Bait can also be placed inside approved bait stations, or similar devices, to ensure product is inaccessible to children or pets, and said devices should be placed in areas where cockroaches are active.

- 8. Bait placements should be inspected periodically for consumption and reapplied as necessary.

#### Product expiry date

2 years from the date shown on the individual syringe label.

#### Precautionary measures

- 1. Handling & storage
- · Avoid contact with skin, eyes and clothing. Before use, read all instructions and directions for use.
- Wear suitable protective clothing and gloves.
- Wash thoroughly with soap and water after handling the product.
- Store in original packaging in a locked, well ventilated, dry place, avoiding extremes in temperature, that is inaccessible to children and non-professional people. Keep out of reach of children.
- Store away from food, drink and animal feeding stuffs.
- No special restrictions on storage with other products.
