SIGNS OF POISONING: Difenacoum is an anticoagulant which may produce bleeding; this may be delayed for several days after exposure.

FIRST AID: If swallowed, seek medical advice immediately and show this container or label.

ANTIDOTE: Vitamin K1 (under medical supervision). UK medical professionals should contact the National Poisons Information Service for further advice.

STORAGE: Keep the product in the original packaging, tightly closed and in a safe place. Keep in a cool, dry, well ventilated area.

DISPOSAL: Poisoned modents (waste code 2001 99) should be disposed of at a suitably permitted incinerator, landfill or burial site by the waste producer or a registered waste carrier. For further information on disposal contact the Environment Agency or SEPA. Remove all baits after treatment and dispose of them in accordance with local requirements. Ratimor™ Difenacoum Wax Blocks

DIRECTIONS FOR USE: Place bat where there are signs of modent activity, like firsh droppings, inside or near nests and burnows, runways and oldent feeding places. Place bait points manally throughout the odent infested area. It is generally much more efficient to use a large number of small but points compared to a smaller number of large bait points, particularly when controlling mice. Large bait points increase the risk to wild-life and to other non-target animals.

 For rat infestations use bait points of up to 200 g. Place bait points 10 m apart reducing to 5m in high infestations. Do not move or disturb bait points for several days after laying bait. If no signs of rat activity are seen near the bait after 7-10 days, move the bait to an area of higher rat activity.

 For mouse infestations use bait points of up to 40 g. Place bait points 5m apart reducing to 2m in high infestations. Mice are very inquisitive and it may help the control program to move baits every 2-3 days at the time when bait points are inspected or topped up.

Make frequent inspections of the balt points during the first 10-14 days and replace any balt eaten by rodents or that has been damaged by water or contaminated by dirt. If all the balt has been eaten from certain areas, increase the quantity of bait by placing more balt points. Do not increase the balt point size. As with all anticoagulant rodenticides, rodents will only die a few days after consuming the balt, typically 4-10.

The bait product can potentially be used under many different circumstances and can be deployed using various means. Methods of deployment for protessional users are bait stations (tamper pool boxes), bait protein makeshift arrangement which uses materials and/or the local environment to restrict access to the bait), loose but inaccessible (an arrangement which uses the local environment only to restrict access to the bait) or in sewers. Baits can be placed in bait boxes which may be fixed to the ground. The bait in such bait boxes can also be secured in place to minimize removal and dispersal by rodents. The product may also be placed on trays under a tile or located in such a way that access by non-target organisms is restricted. The product must never be naced indiscrimately.

LONG-TERM USE: Unless under the supervision of a pest control operator or other competent person, do not use anticoagulant rodenticides as permanent baits. In most cases, anticoagulant bait should have achieved control within 35 days. Should activity continue beyond this time, the likely cause should be determined.

PUBLIC AREA ÚSE: When the product is being used in public areas, the areas treated must be marked during the treatment period and a notice explaining the risk of primary or secondary poisoning by the anticoagulant as well as indicating the first measures to be taken in case of poisoning must be made available alongside the baits.
EFFECT: Differacoum prevents the formation of prothronbin in blood and this causes haemorrhage and the death of a rodent. The product is effective soon after swallowing. The death of individual nodents does not influence the resistance to baits among other rodents that are still alive. It is effective against rodents resistant to anticoagulant modenticides of the first generation.

PRECAÚTIONS AND CONDITIONS FOR SAFE USE: The resistance status of the target population should be taken into account when considering the choice of ordenticide to be used. Avoid all contact by mouth. Wash hands and exposed skin before meals and after use. Balts must be excurely deposited in a way as as to minimize the risk of consumption.

by other animals or children. Secure baits so that they cannot be diagoed away. Search for and remove doed orders at frequent intervals during treatment (unless used in severs), at least as often as when baits are checked and/or replenished. Daily inspection may be required in some circumstances. When tamper resistant balt stations are used, they should be clearly marked to show that they contain ordenticides and that they should not be disturbed.
