Application Guidelines

Apply dust as a 'band treatment' to floors and next to wall floor junctions for crawling insect control, or as a 'spot' treatment to cracks and crevices and other harbourages. Apply as a fine surface dust to areas where pests may rest or sit for the control of fleas, lice, ticks and mites. Apply to wasp nests. Use the dust to directly treat ant nests and ant 'runs'. Apply dust as a 'barrier' treatment. This product is ready-for-use and requires no further dilution. Apply product at a rate of 10-25g per square metre. Re-treat as necessary.

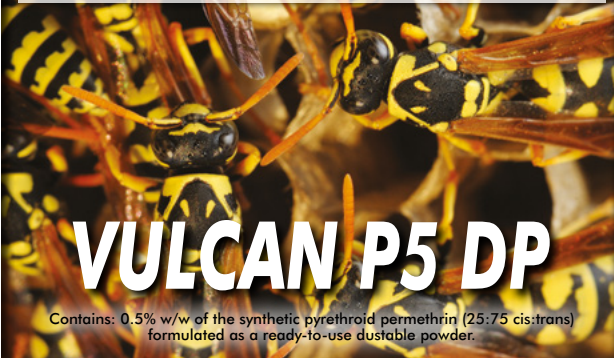
